# TERMS AND CONDITIONS OF SALE

- 1. DEFINITIONS**  
In these conditions "the Seller" means Sonic (U.K.) Ltd, "the Buyer" means the person, firm, Company or Corporation by whom the order is given and the Goods means the goods the subject of the order.
- 2. GENERAL**  
Unless specifically agreed in writing, all goods are sold subject to the following conditions, irrespective of any published conditions of the purchaser.
- 3. PRICES**  
Except as otherwise agreed prices shall be those ruling at the date of despatch and the seller reserves the right to alter the prices of goods without notice whether before or after the formation of a contract in order to take into account any increase or decrease in the sellers general prices appertaining to such or similar goods up to the date of dispatch.
- 4. TAXES**  
Except as otherwise agreed, Value Added Tax and all other taxes of any nature whatsoever now or hereafter levied either directly upon the sale or delivery of the goods covered hereby or upon the subject matter hereof shall be borne by the Buyer.
- 5. PAYMENT**  
A discount of 2.5% is deductible for payment within 30 days of the date of invoice otherwise strictly net 15<sup>th</sup> month following month of invoice.
- 6. DELIVERY**  
Whilst every effort is made to minimise delivery time, the Seller shall not be liable for any loss or damage arising from late or non-delivery.  
Where goods are ordered for delivery by instalment, Sonic (U.K.) Ltd shall have a right to dispose of such goods as are not taken on the specified delivery dates.  
Unless otherwise specified goods are delivered within 72 hrs, carriage paid, to any part of the UK on orders not less than £200.00 net in value. Orders less than £200.00 net in value will be subject to a minimum carriage / order charge of £6.00.
- 7. QUOTATION**  
The acceptance of a quotation will not imply a binding contract unless and until it has been confirmed in writing by the Seller.
- 8. BACKORDERS**  
Unless otherwise specified, out of stock lines will be placed on backorder and will be supplied automatically up to 120 days from that order date, unless notification is received of cancellation.
- 9. PASSING OF PROPERTY AND RISK**  
The property and legal title in the goods supplied hereunder shall not pass to the Buyer until all the goods sold hereunder and all other goods the subject of any other contract between the parties which, at the time of payment of the full price of the goods sold under this Contract, have been delivered to the Buyer but not paid for in full, have been paid for in cash in full.
- 10. FORCE MAJEURE**  
The Seller shall not be liable for failure to deliver or delay in delivery by reason of the following matters namely : force majeure, existing or future strikes or other labour troubles, inability to gain necessary materials or services from usual sources of supply or any other cause whatsoever beyond the control of the Seller. In the event of such delays as aforesaid the Seller shall have the right either to suspend deliveries without notice or cancel the contract without liability.
- 11. RETURN OF GOODS**  
The seller will not accept the return of goods of faulty manufacture without written notification, which must state the nature of the fault of each item and the invoice number relating to the purchase of each item.  
All transportation charges relating to the return of goods will be borne by the Buyer unless otherwise agreed in writing.  
We will, at our option, replace wherever possible goods found to be of faulty manufacture after examination provided that the procedure for returns above has been complied with. The Seller will return goods that, after examination, are found to have no fault or defect.
- 12. CREDITS**  
If goods are credited it will be at the original purchase price as referred to by the invoice number listed on the return note and agreed by our company. In the event of receivership or insolvency of the Buyer, credits will only be made against pre-existing indebtedness of the Buyer.
- 13. NEW ACCOUNTS**  
Unless a credit account is established, all business will be on a cash sale basis.  
A new account should furnish two satisfactory trade references and a bank reference.
- 14. DESCRIPTIVE MATTER**  
All leaflets, specifications, drawings and particulars of prices, weights, dimensions and performances issued by the Seller or the manufacturers of equipment are approximate only and are not intended to be the basis of any contract between the Buyer and the Seller.
- 15. JURISDICTION**  
All contracts for the sale of goods to the Buyer shall be governed by English Law and shall be within the exclusive jurisdiction of the courts of England.
